
## The WTO and the Uncertain Future of Multilateralism Cato Institute, October 2, 2013

## **Speaker Biographies**



**Mike Moore** is a past Director-General of the World Trade Organisation (WTO). Mr Moore oversaw the launch of the Doha Development Round. His period in office saw the successful accession to the WTO of China and Chinese Taipei along with Estonia, Jordan, Georgia, Albania, Oman, Croatia, Lithuania, and Moldova.

Mr Moore is a former Labour Prime Minister of New Zealand. He held portfolios in a wide range of areas and served in a number of senior political

positions including Trade Minister, Foreign Minister, Minister of Tourism, Minister for the Americas Cup and Deputy Minister of Finance. Mike Moore worked as a meat and construction worker, and a printer where he became an active Trade Unionist. He became a social worker in a hospital for the criminally insane – an experience he claims "prepared him well for a life in politics".

Mr Moore held numerous appointments and board memberships with global policy and commercial organisations. These included Membership of the United Nations Commission on the Legal Empowerment of the Poor; Commissioner for the UN Global Commission on International Migration; and a number of private sector boards. Mr Moore served on the Economic Development Board of South Australia, and was an advisor to other Governments. He is a Trilateral Commission member and a member of the Privy Council. Mr Moore was an Adjunct Professor at Adelaide University, Australia, and La Trobe University, Australia, is Honorary Professor at Beijing Normal University in Zhuhai; the Chinese University for Political Science and International Law in Beijing; and Shanghai Customs College.

Mr Moore is the recipient of numerous honours from governments in Africa, Europe and South America. He was awarded New Zealand's highest honour, the Order of New Zealand. Mr Moore also holds honorary doctorates in commerce from Lincoln University, New Zealand; in economics from the People's University of China, Beijing; in commerce from Auckland University of Technology and Canterbury University, and law from La Trobe University in Australia.

He is the author of ten books including: A Pacific Parliament; Hard Labour, Fighting For New Zealand; Children of the Poor; A Brief History of the Future and A World Without Walls. Mr Moore's latest book, "Saving Globalisation", was published by Wiley's in 2009. Mr Moore is the founder of a New Zealand Charity "School Aid" which creates investment funds which are managed by High School students, the profits of which will go to schools in developing countries.



**Jennifer Hillman** is a partner in the law firm of Cassidy, Levy and Kent and a fellow and adjunct professor of law at the Georgetown University Law Center's Institute of International Economic Law. Her work focuses on the WTO dispute settlement system, the WTO agreements related to trade remedies, and WTO jurisprudence related to trade remedies. From 2007-

2011 she served as one of the seven members of the WTO's Appellate Body, the final adjudicator of international trade disputes.

From 1998 to 2007, Hillman served as a commissioner at the U.S. International Trade Commission. From 1995 to 1997, Hillman served as General Counsel to the USTR, where she was responsible for a wide variety of trade matters, including all U.S. government submissions in dispute settlement cases before both the World Trade Organization and North American Free Trade Agreement panels, as well as all legal work done in connection with trade negotiations.

Prior to that, Hillman served as Chief Textile Negotiator with the rank of Ambassador for the USTR, where her responsibilities included negotiating bilateral textile agreements with 38 countries in 1993-1994. Before joining the USTR, Hillman served as the Deputy Cluster Coordinator for Financial Institutions for the Presidential and Vice Presidential transition.

Hillman also served as Legislative Director and Counsel to U.S. Senator Terry Sanford of North Carolina, responsible for international trade, banking, securities and finance issues. She began her professional career as an international trade attorney in the Washington firm of Patton, Boggs, LLP. She has a Bachelor of Arts and Master of Education from Duke University, North Carolina, and a Juris Doctor degree from Harvard Law School.



**Craig VanGrasstek** is an Adjunct Lecturer in Public Policy at the Harvard Kennedy School, and according to *The Economist*, "keeps a sharp eye on the politics of trade." His firm, Washington Trade Reports, specializes in monitoring and analyzing current issues in trade policy. He has worked as a consultant in nearly four dozen countries on five continents, with expertise in the fields of trade negotiations, preferences and free trade agreements, WTO accessions, dispute settlement, trade in services, and the trade policy making process of the United States. His clients include the World Trade Organization (WTO), the

Organization for Economic Cooperation and Development (OECD), the United Nations Conference on Trade and Development (UNCTAD), the World Bank, and other international organizations, as well as government agencies and private firms.

He holds a doctorate in political science from Princeton University and a Master of Science in Foreign Service degree from Georgetown University. He has taught trade policy at Harvard University and American University, and also teaches an innovative course at Georgetown University on foreign policy and literature. In addition to numerous reports to international organizations, book chapters, and journal articles, Dr. VanGrasstek's publications include (with Stephen Lande) *The Trade and Tariff Act of 1984: Trade Policy in the Reagan Administration* (1986), and *The History and Future of the World Trade Organization* (Geneva, 2013).
