Laguna Niguel, CA received an Immigration Alien Response (IAR) from the ICE Law Enforcement Support Center (LESC) on subject was encountered at LA NORTH WEST/VAN NUYS COURT due to an arrest for 14601.5(A) VC-DRIVE:LIC SUS/ETC:DUI/RFUSE TST. Subject's fingerprints were

electronically submitted to CA DOJ, NCIC/IAFIS and DHS/ICE databases. Upon review of database information it was determined that the Subject was amenable to DHS/ICE enforcement action as being a LPR. Based on this information an ICE Immigration Detainer was lodged.
