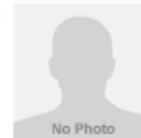

**I-213 Narrative \*\*\*\*\*UPDATE\*\*\*\*\*** The subject was interviewed at Robert Presley Detention Center, in Riverside, California on December 24, 2013. During the interview he stated that he was born i [Redacted], Arizona under the nam [Redacted] DOB [Redacted] The mother also provided a birth Certificate, which was confirmed by the Arizona Department of Health Services. Subject is not amenable to removal, as the subject's country of citizenship is the United States, and the ICE hold will be lifted. On 11/21/2013 Southern California Secure Communities Support Center (SC3), Laguna Niguel, CA. reviewed an Immigration Alien Response (IAR) from the Law Enforcement Support Center (LESC) fo [Redacted], who was arrested in RIVERSIDE County, CA for the following: DOMESTIC VIOLENCE, THREATEN. The fingerprints of the subject were electronically submitted to CA DOJ, NCIC/IAFIS and DHS/ICE databases. Upon review of database information it was determined that subject was amenable to DHS/ICE enforcement action with the following status: EWI. Based on this information an ICE Immigration Detainer was lodged.
