16. Other than a direct appeal from the judgment of conviction and sentence, have you previously filed any petitions, applications, or motions with respect to your confinement in any court, state or federal? Yes. I previously filed a petition for writ of habeas corpus pursuant to 28 U.S.C. § 2241 with this Court. See 04-cv-00367 (Lasnik, J.). On April 7, 2004, the petition was dismissed without prejudice.

17. GROUNDS FOR RELIEF:

- A. My family came to the United States in 1984 as refugees from what was at that time Ethiopia. My family, however, is ethnically, culturally, and geographically from Eritrea, not from Ethiopia. My family has identified itself as Eritrean and are recognized as citizens of Eritrea, not Ethiopia.
- B. My mother became a naturalized United States citizen on May 3, 1995. At the time, my parents were legally separated, I was under the age of 18, and my mother had custody of me. Pursuant to former 8 U.S.C. § 1431(a)(3), INA § 320(a)(3), repealed by Pub.L. 106-935, Title I, § 103(a), Oct. 30, 2000, 114 Stat. 1632, I automatically obtained derivative citizenship when my mother was naturalized.
- C. On March 1, 2001, I was ordered deported to Ethiopia. The deportation was predicated on the erroneous belief that I was a legal permanent resident rather than a United States citizen.
- D. ICE was unable to remove me to Ethiopia because the Ethiopian consulate had determined that I am Eritrean and not Ethiopian and had refused to issue travel documents for me. Accordingly, on March 30, 2004, ICE released me from immigration custody pursuant to the Supreme Court's holding in Zadvydas v. Davis, 533 U.S. 678 (2001).
- E. I remained on release until September 13, 2006, when ICE again took me into custody. Despite the fact that Ethiopia had previously determined that I am not Ethiopian but am, in fact, Eritrean, ICE informed me that it expected to obtain travel documents to Ethiopia. ICE initially said that it had no evidence in its files that I had ever been interviewed by the Ethiopian consulate and insisted that I was Ethiopian.
- F. Because I am a United States citizen, my continued detention by ICE is unconstitutional.
- G. Because I am a United States citizen, ICE has no statutory authority to detain me.
- H. Because I am seeking relief related only to my custody status, exhaustion of administrative remedies, if any, is not required.
- I. My detention is unconstitutional, because I am not a flight risk, and I am not a danger to society.
